Retired Employee Travel Pass Information

You may be eligible for a Retired Employee Travel Pass if you were employed by the Public Transport Corporation (PTC) and/or its predecessors prior to the privatisation of public transport in 1999.

To apply for a Retired Employee Travel Pass, Public Transport Victoria (PTV) requires the details of your employment history with the PTC, as well as your service history with any franchise or non-franchisee operators after privatisation in 1999.

A formal statement of service outlining your public transport service history is required and must include the following information:

- Employment commencement date
- Employment separation date
- Reason for separation
- Confirmation of date of birth

If you require a statement for your PTC service prior to 1999, complete the 'Public Transport Statement of Service Application Form' on page 3.

If you have recently retired from a franchise/non-franchisee operator, you'll need to obtain your statement of service from your most recent employer. If this service was a continuation of your employment with the PTC and subsequent private operators, your most recent employer can provide you with a statement of service which also includes your service prior to privatisation in 1999.

Public Transport Statement of Service Application Form

To obtain a statement of service for your public transport service prior to privatisation in 1999, you'll need to make an application to the Department of Economic Development, Jobs, Transport and Resources (DEDJTR).

Once DEDJTR receives your application, a statement of service will be prepared and sent to you in the mail within four weeks. Enquiries about the status of your application can be made to the DEDJTR Risk Team on (03) 8392 6701 (business hours), after the standard four weeks processing period has passed.

A copy of your statement of service will also be sent to the PTV Hub in support of your application for a Retired Employee Travel Pass. The PTV Hub will contact you within 10 business days advising of the outcome of your application.
